Dear Rachel,

I believe that taking my failed AHPRA notification of Dr. Hillol Das to Lynn Griffin once more at the Health Services Commissioner would be a backward step and the only way forward is to have the Health Practitioner Ombudsman provide me with a second corrected response to the concerns that I have raised and as a consequence take whatever legal actions it believes to be indicated.

Hence I have attached my failed notification to AHPRA and their response to me.

I believe that when the breach of law is beyond dispute the least the medical board could do is admit the breach and put legal measures in place to ensure that it is not repeated by Dr. Hillol Das or anyone else.

I believe that Dr. Hillol Das is simply "the opposition" and he is abusing the tools of the medical profession ( especially the crisis assessment team ) in a war against the patient that is 100% anti-patient with psychiatric window dressing.

Dr. Hillol Das needs to have some rigid legal guidelines laid down for him so as to prevent him from further damaging a future patient unfortunate enough to go to him for treatment. These rigid legal guidelines should as a consequence apply to all authorized psychiatrists.

I would have thought that the mental health act 2014 is there to provide a somewhat imperfect set of legal guidelines but Dr. Hillol Das seems to feel that he is above the law and the medical board agrees with this view. In my opinion, Dr Hillol Das satisfies the very definition of un-professional.
