Thank you for your complaint dated 28 August 2017 and further email dated 15 September 2017 about the Mental Health Complaints Commissioner (MHCC).

You have requested that the Ombudsman instruct the Minister for Mental Health to instruct the MHCC to send "2017.04.18 IDEAL SOLUTION.pdf" to Dr Atanas Yonchev.

In response to my request for you to clarify your concerns in regards to the MHCC you have reiterated via email dated 15 September 2017, that you want the MHCC to send the above document to Dr Yonchev.

Our office is able to consider most complaints about the actions and decisions of MHCC under the Ombudsman Act 1973. However, it is not our role to instruct agencies on how to perform their functions.

You have provided letters from MHCC to yourself, dated 7 August and 16 August 2017. These letters show that your complaint was closed after Dr Yonchev provided information from your clinical file about the changes in your medication. You have not provided information on actions or decisions of MHCC that may be unlawful or unreasonable.
