## **THE CON-SEQUENCES OF MIND**

MIND in "absolute isolation" will **REALIZE** "EVERYTHING".

MIND in "absolute isolation" is logically constrained 2 follow an

ABSOLUTE and UNIQUE sequence of "discrete realizations".

The sequence "goes something" like this: -

I am aware that I am a "discrete entity"

(and, because I exist in "absolute isolation")

(( I can only conceive of the "fundamental quality" MIND ))

I can and insist upon the "concept" of a MIND that can "completely understand" all the "discrete entity" I can "conceive" of.

(I will call her "Jenny")

I can and insist upon the "conception" of a countably infinite number of "<u>discrete something</u>" where each "<u>discrete something</u>" is "understood" by only 1 "discrete entity" and Jenny.

By symmetry,

I "conceive" of a "discrete something" as being

- 1) What was "understood" as MIND "completely understands" a "discrete entity".
- 2) What was "understood" as MIND "completely understands" a "discrete entity".
- (Mind 1 cannot "understand" other "discrete entity" because then a "discrete something" would be "understood" by more than 1 "discrete entity" and "Jenny".)
- (Mind 2 cannot be me because a "discrete entity" "understands" "something" I do not, so it can only be "Jenny".)
- Note :- a "discrete entity" is a MIND that I can "conceive" of that "understands" something I do not.

David "WANTS" to "understand completely". At this point David does not even understand a single "discrete something".

He "realizes" that Jenny is a concept he has conceived of but does not despair.



- For a discrete packet of "information" to exist we need there to exist 2 discrete entity. All discrete packets of "information" are in reality the "description" of the relationship between 2 discrete entity.
- There exist three "fundamental" discrete packets of "information" and they are expressed in "ENGLISH" by the terms "permit", "bidden" and "insist".
- The "information" understood by "The Mind in absolute isolation" when he understands "the existence of discrete integers" is best understood to be the "consequence" of the relationship between any two discrete entities that he can conceive of.
- The "information" involved in the "understanding" of "countably infinite" is expressed in reality by the "second" most "fundamental" "rule" of creation.

- When the "POSITION" of a "discrete entity" does not "vary" with "TIME", instead of its uncertainty in "TIME" being considered infinite, we consider it's "ENERGY" to be expressed as "MATTER".
- In our Universe, the "fundamental" qualities "POSITION" and "TIME" "initially" did not "vary" with respect to each other for all "discrete entity" in it.
- This "initial" "condition" gives additional support for my proposition to use "POSITION" and "TIME" when mirroring the "Uncertainty Principle".
- This relationship between "POSITION" and "TIME" is reflected in the "fundamental" constant "c" or "the speed of light" and suggests that "initially" all "ENERGY" was expressed "ELECTRO-MAGNETICALLY" as indicated by our detection of microwave background radiation.
