I WANT TO PROPOSE THE FOLLOWING AGREEMENT:-\ 0 |-|

(a) You agree that in the future the task of certifying me unacceptably ill lies with my family.

(If they feel my behavior necessitates hospitalization, I will voluntarily go to hospital and allow myself to be broken down by medication but I will only continue to voluntarily take medication while I deem it is not a maintenance dose.)

- (b) You agree that while my family believe I do not require hospitalization, I am uncertified.
- (c) You agree to administer only 5 more doses of Haldol tranquilizer.

(As a period of 6 months is required to completely heal the effects of the nervous break down initiated by the administering of medication.)
