After managing to get Microsoft Ads to finally accept my VISA card I set up post pay once my account balance had fallen to the designated trigger point.

It was then that the Microsoft automatic systems deemed both my ad campaigns egregious once more.

I can understand my smart campaign cloned from Google Ads being deemed egregious because I choose to express myself without limiting profanity from my language.

However, my expert campaign for Proclaim Anglican Church was largely AI generated from <https://www.proclaim.org.au/> and there can be no excuse for deeming a church to be egregious.

Judging from your email Heather, I think that you understand that a further review will not resolve the issue, so I am now formally requesting that Microsoft refund my un-used account balance of \$1,650.70 as I have yet to receive even one ad impression service.



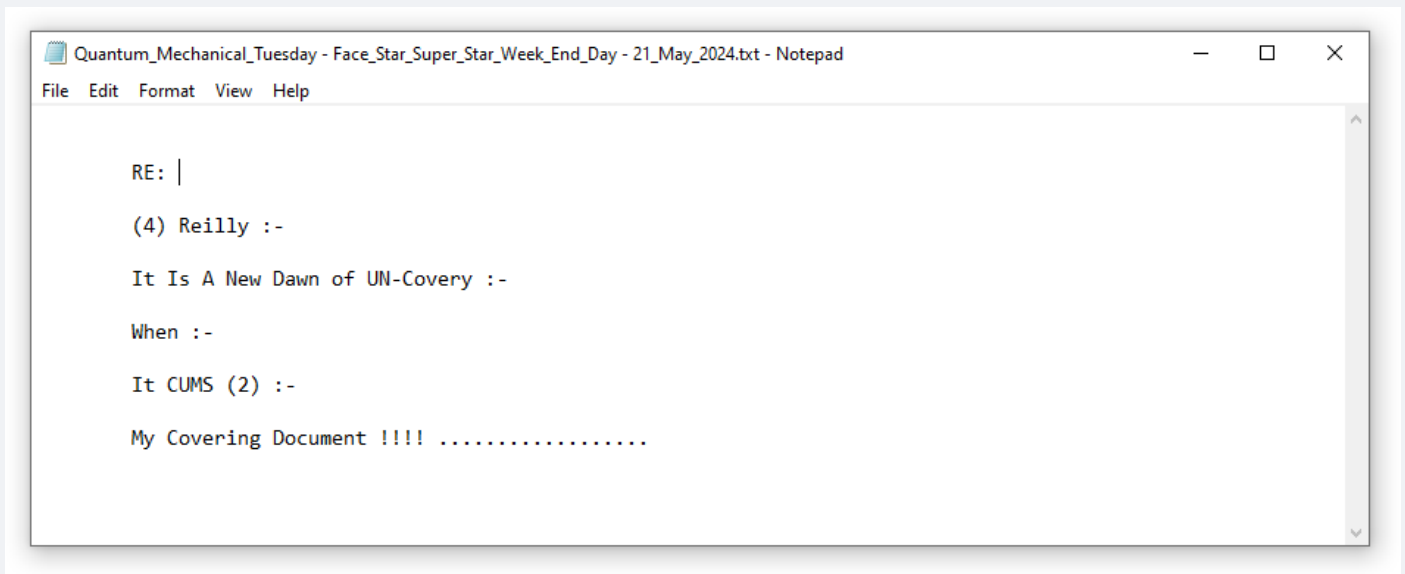

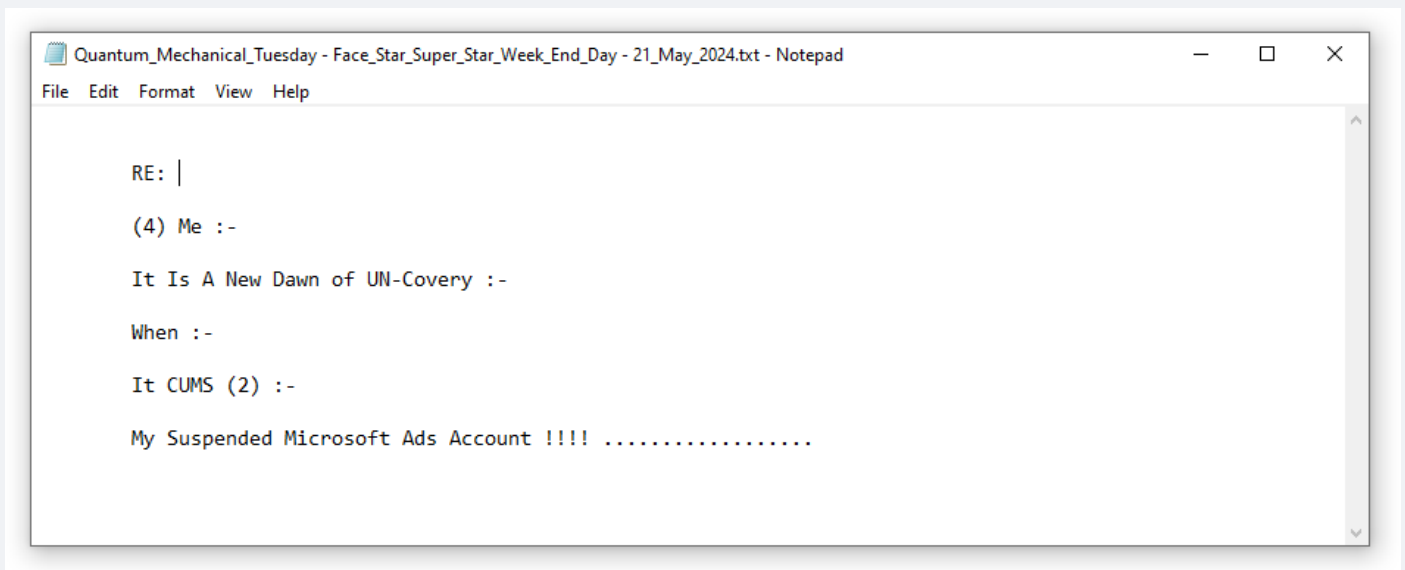

I am writing to you in regard to Mr David Crofts since he has been corresponding with me intermittently since his admission to Peninsula Health in February 2000. During his admission we treated him as an out of area patient and made a report to VicRoads that we believed he was not safe to drive. On discharge from our Service in 2000 he was on a Community Treatment Order to Dandenong Area Mental Health Service and I have no knowledge of his further treatment there.

He wrote to me for some months after the admission regarding his not safe to drive. Only last week he again conducted a correspondence with me. My concern was that this correspondence exploded with bizarre, unusual objections, false Peninsula Health letterheads.

It is clearly consistent with a relapse of his chronic schizophrenia and suggests that he may again pose a potential risk both to himself and to other people.

Dear Sir/Madam,

I write to inform you that I choose not to attend the appointment you have made for me at Dandenong Hospital on Monday, 30<sup>th</sup> June 2003 at 1:30 PM and will instead attempt to defuse the situation with this document.

I understand that your concerns are based on a private letter I sent to Dr. John Reilly on Friday, 30<sup>th</sup> May 2003. As this is one month ago I hope you can appreciate the situation is not urgent. I currently receive an injection of Fluaxol fortnightly from Laurie Disting and see no need to alter my treatment in any way. He detected no change in me when he saw me last (one week ago) and as he knows me quite well I think you should respect his judgment. From my point of view, my state of mind is the same as it always been since I accepted treatment with Fluaxol.

Anyway, I will attempt to address your concerns.

As the covering letter to Dr. Reilly only makes oblique references to matters addressed in the main document you can dismiss it and concentrate only on "David Crofts' Personal Reality". Since I first detected this reality in 1984, I have had over 10 Hospital admissions and my belief in it has never been changed. I have also been tried on multiple medications and their effect has in no way changed my beliefs. Hence, there seems to be no way you altering my treatment will change my views on reality.

Please Note :- My personal reality should only become a concern of yours when it means that I am a danger to myself or other people. Quite clearly, if I choose to deport myself in accordance with my personal reality as I have described it, it means I'm a danger to no one.

When I wrote this document in 1997, I thought it was forbidden to have a personal reality. If you have a personal reality please grant me mine.

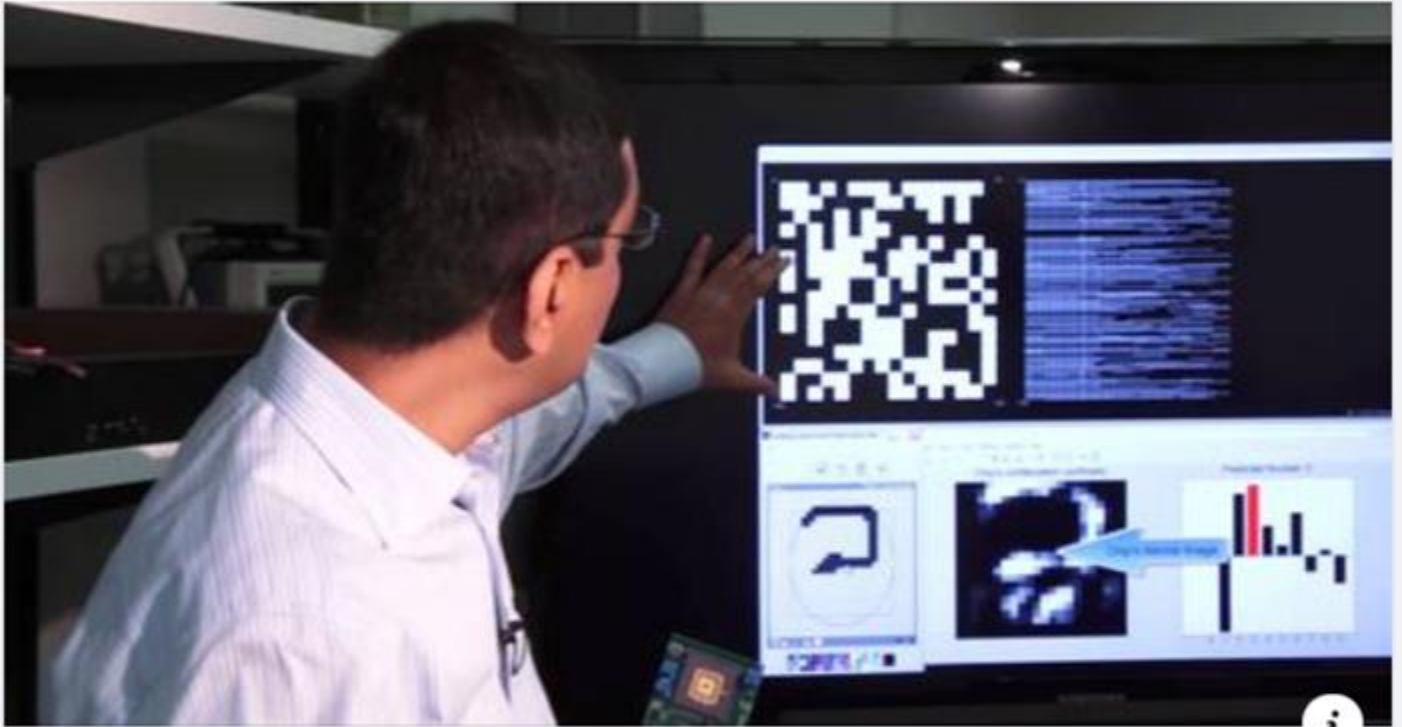
