I attend a psychosocial rehabilitation service where I recently heard someone describe their experience of the mental health service.

Although she does not seem to be able to muster the righteous indignation to complain, I can not let the matter rest.

After a sequence of irrelevant events she found herself outside the seclusion cell of a psychiatric hospital. She was clearly compliant as she obeyed the following instructions before being medicated and placed in seclusion.

She was asked to undress in the presence of hospital staff and go to the lavatory while they observed.

I am not saying I can not understand the need for this procedure or even that I can not appreciate it as necessary, but I am insisting that you provide a justification as to why it is positive.

Dear Mr Crofts

Thank you for your letter of 16 January 2000. I understand that you are concerned at a description given by a patient of their experience of having being placed in seclusion and to having been observed by hospital staff while undressing and going to the lavatory.

Although I am unable to comment on this specific **instance** from the limited details you provide, I would emphasize that seclusion is strictly **regulated** under the Mental Health Act. Guidelines regarding seclusion are distributed from the Office of the Chief Psychiatrist, and emphasize the need for a **person** to be treated in as dignified a manner as possible. Seclusion is generally used only when there is significant concern of there being imminent risk that that person will harm themselves or others. At times, the risk of self harm is such that the person does need to be under continuous observation. However, this should always be done with full explanation to the patient and with very frequent review to determine whether the person can be safely managed in a less restrictive manner.

If you have particular concerns relating to a specific incident, then it may be more appropriate that you seek advice from the service involved, or at least encourage your acquaintance to seek explanation of that particular aspect of his or her management and care.

I thank you again for your correspondence. The Office of the Chief Psychiatrist has a role in ensuring that services do comply with the requirements of the Mental Health Act, and in monitoring that services provide care that is mindful of personal dignity and of the need to minimize intrusion into a persons physical liberty.
